PHD COLLOQUIUM

The colloquium is held face-to-face during the upcoming Pacific Rim Real Estate Society 31st Annual Conference on Sunday 12th January 2025 in Hobart, Tasmania, Australia

We would welcome PRRES Inc members encouraging their PhD students to register for the event which provides the opportunity for PhD students in Property related research, to present their PhD work-in-progress within a supportive environment.

PRRES is offering scholarships valued up to AUD\$1,500 available to full time PhD students at a University in the broad PRRES Inc catchment area (Pacific Rim area), and at least one of the supervisors must be a current financial PRRES Inc member. In addition, there are awards for PRRES Inc Early Researcher PhD Prize, and best PhD Presenter at the colloquium.

To present at the colloquium, students are required to submit a 3 page research summary with a 150 word abstract to Dr Wejen Reddy wejendra.reddy@rmit.edu.au by no later than the 15th August 2024, and register for the 2025 PRRES Conference by 31st October 2024. The acceptance will be notified before 30th September 2024. The registration fee for PhD students, is the same as the early bird conference rate registration.
